AMENDED SCHEDULING ORDER

Pursuant to Board Rules of Procedure 101.4, the Board issues the following Scheduling Order herein:

July 22, 2011	District shall file the Appeal File.
July 22, 2011	District shall file the Answer to the Complaint.
October 26, 2011:	All written discovery requests shall be made by this date.
January 13, 2012	All non-expert discovery shall be completed by this date.
March 16, 2012	The parties shall exchange witness lists.
March 23, 2012	Appellant’s expert report shall be disclosed.
April 13, 2012	The District’s expert report shall be disclosed.
May 16, 2012	All expert discovery shall be completed by this date.
June 15, 2012:	The parties shall file all dispositive motions by this date.
July 20, 2012:	Parties shall file proposed Joint Pretrial Statement with the Board including respective exhibit and witness lists, and statement of stipulated facts. The Board shall be given a tabbed, indexed single courtesy copy (3 ring binder) of the Appeal File and Appeal File Supplement exhibits.
September 24, 2012	Prehearing Conference at the Board, beginning at 11a.m.
October 23, 2012:	Hearing on the merits of the claims in the Board courtroom at 10:00 a.m. daily and shall conclude no later than October 25, 2012. The District shall provide a court reporter.

Absent good cause shown, a party's final witness list shall only persons identified to the opposing party as ordered herein; persons not included on such witness list will not be permitted to testify at the hearing; and exhibits not exchanged as ordered herein will not be received in evidence, except for exhibits to which no objection has been raised, demonstrative exhibits prepared at trial, and rebuttal exhibits.

The parties are encouraged to pursue settlement throughout these proceedings. Settlement conserves resources and, where pursued early, may prevent delays. The Board is available to assist the parties with settlement discussions upon request.

This scheduling order may be amended only by leave of the Board upon motion properly filed and served. All motions shall be in writing, and filed in accordance with the Board's Rules of Procedure. All motions requesting extension of a deadline, or continuance of a hearing or conference, shall be filed in accordance with 27 DCMR § 124 et seq. Such motions shall also include proposed dates that are mutually agreeable to all counsel and/or unrepresented parties.
