<u>April 29, 2015</u> :	Prehearing conference at the Board, beginning at 1:00 p.m.
<u>June 2, 2015</u> :	Hearing on the merits of the claims in the Board courtroom at 10:00 a.m. daily to conclude no later than June 5, 2015. The District shall provide a court reporter.

The parties are encouraged to pursue settlement throughout these proceedings. Settlement conserves resources and, where pursued early, may prevent delays. The Board is available to assist the parties with settlement discussions upon request.
