**ORDER TO EXTEND TIME**

On November 20, 2014, the District filed a motion to enlarge the amended scheduling order herein. Good cause having been shown and no opposition filed, the order is granted. Accordingly, the Board's Amended Scheduling Order is revised as follows, retaining June 2, 2015, as the scheduled date for the hearing on the merits.

January 19, 2015: All non-expert discovery shall be complete by this date, and, Appellant's expert report shall be disclosed.

February 17, 2015: District's expert report shall be disclosed.

March 4, 2015: All discovery shall be completed by this date.

March 23, 2015: The parties shall file all dispositive motions by this date.

April 17, 2015: Parties shall file a proposed Joint Pretrial Statement with the Board including respective exhibit and final witness lists, statement of stipulated facts, and statement of stipulated costs (if any). The Board shall be given a single CD and tabbed, indexed single courtesy copy (3 ring binder) of all exhibits the parties plan to introduce as evidence at the trial hereof.

April 29, 2015: Prehearing conference at the Board, beginning at 1:00 p.m.

June 2, 2015: Hearing on the merits of the claims in the Board courtroom at 10:00 a.m. daily to conclude no later than June 5, 2015. The District shall provide a court reporter.

The parties are encouraged to pursue settlement throughout these proceedings. Settlement conserves resources and, where pursued early, may prevent delays. The Board is available to assist the parties with settlement discussions upon request.

This scheduling order may be amended only by leave of the Board upon motion properly filed and served. All motions shall be in writing, and filed in accordance with the Board's Rules of Procedure, and such motions shall also include proposed dates that are mutually agreeable to all counsel and/or unrepresented parties.
